

RESOLUTION #24-1217B

A RESOLUTION AUTHORIZING THE VILLAGE OF ASHMORE, ILLINOIS TO ENTER INTO AN AGREEMENT WITH MAGUIRE IRON, INC FOR WATER TOWER MAINTENANCE SERVICES

WHEREAS, the Village of Ashmore (hereinafter "the Village") is a duly organized municipality under the laws of the State of Illinois; and

WHEREAS, pursuant to the Illinois Municipal Code (65 ILCS 5/8-1-7), the Village is authorized to establish and maintain waterworks and to make all necessary contracts for the construction, maintenance, and operation of such facilities; and

WHEREAS, the Village owns and operates a water tower that is vital to the provision of potable water to its residents and businesses; and

WHEREAS, the Village has determined that regular maintenance of the water tower is necessary to ensure its proper functioning, structural integrity, and compliance with all applicable health and safety standards; and

WHEREAS, Maguire Iron, Inc. ("Contractor"), is a qualified and experienced provider of water tower maintenance services, and the Village has determined that entering into an agreement wih Contractor is in the best interest of the Village and its residents; and

WHEREAS, the Village Board of Trustees has reviewed the proposed agreement with Contractor and finds it to be fair, reasonable, and in the best interest of the Village.

Now, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Ashmore, Illinois as follows:

SECTION 1:

The Village President and Village Clerk are hereby authorized and directed to execute and attest, respectively, the agreement with Maquire Iron, Inc., for water tower maintenance services, a copy of which is attached hereto as Exhibit A and incorporated herein by reference.

SECTION 2:

The Village Board of Trustees hereby authorizes the expenditure of funds in accordance with the terms of the agreement, subject to the Village's approved budget.

SECTION 3: EFFECTIVE DATE:

This Resolution is effective immediately upon passage and shall remain in effect until rescinded or superseded by the Village Board of Trustees.

The provisions of this Resolution are hereby declared to be severable, and should any provision of this Resolution be determined to be in conflict with any law, statute, or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain in full force and effect. All resolutions, rules and orders, or parts thereof in conflict herewith are, to the extent of such conflict, hereby superseded.
