If you no longer own the vehicle, please notify the Clerk's office so that we may update our records. Please note that the NHV Permit sticker belongs to the person who registered for it. The NHV Permit Sticker is not transferrable to other people, but it may be transferred to a new NHV if the new NHV is owned by the same person who originally registered for the sticker. Please notify the Municipal Office if you have purchased or traded-in for a new NHV.

_____ I hereby certify that I maintain valid liability insurance in accordance with state statute.

_____ I hereby acknowledge and renew the waiver of liability which I signed with my original application, a copy of which is available to me at the Municipal Office at any time upon request.

_____ I hereby acknowledge and understand that my permit is valid within the corporate limits of the Villages of Ashmore, Westfield, and Kansas, and the City of Oakland; and that I must act in accordance with the respective ordinances of each community. I further understand that my permit does not authorize the operation of my NHV outside of the corporate limits listed above, nor on highways within corporate limits, nor on any private property without permission of the property owner.

_____ I hereby acknowledge and understand that it is illegal to operate a NHV without a valid driver's license, in accordance with Ashmore Village Code and state statute.

_____ I hereby agree that any NHV that is owned by me and/or in my possession shall be operated in accordance with Ashmore Village Code (Title 5, Ch. 4), the Illinois Vehicle Code, the Illinois Compiled Statutes (625 ILCS 5/11-1426.1).

_____ I hereby acknowledge and agree that if any information provided herein is false or if my NHV is witnessed to be non-compliant while in operation on public properties, streets, or right-of-ways, then I may be subject to warnings, fines, and/or revocation of my permit.
