

RESOLUTION #R25-0422C A RESOLUTION TO APPOINT BOARD MEMBERS TO STANDING COMMITTEES OF THE VILLAGE BOARD

WHEREAS, the Village of Ashmore (hereinafter "the Village") is a duly organized municipality under the laws of the State of Illinois; and

WHEREAS, pursuant to the Illinois Municipal Code, 65 ILCS 5/3.1-35-5, the Village President has the authority to appoint members of the Board of Trustees to committees of the corporate authorities, subject to the advice and consent of the Board of Trustees; and

WHEREAS, the efficient and effective operation of Village government requires the assignment of Trustees to various standing committees to oversee areas such as finance, streets and alleys, water and sewer, public safety, and other municipal functions; and

WHEREAS, the Village President has prepared a list of proposed committee appointments, which is attached hereto as *Exhibit A* and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Ashmore, Coles County, Illinois as follows:

SECTION 1: AUTHORIZATION TO APPOINT:

The Village Board hereby affirms the authority of the Village President to appoint members of the Board of Trustees to the standing committees of the Village.

SECTION 2: CONSENT OF THE BOARD:

The Village Board hereby consents to the appointments set forth in Exhibit A, as made by the Village President.

SECTION 3: EFFECTIVE DATE:

This Resolution shall be in full force and effect immediately upon its passage and approval by the Village Board. The provisions of this Resolution are hereby declared to be severable and should any provision of this Resolution be determined to be in conflict with any law, statute, or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain in full force and effect. All resolutions, rules and orders, or parts thereof in conflict herewith are, to the extent of such conflict, hereby superseded.
